Important message about COVID-19

As from Monday 13 December 2021, the government will be introducing extra Band B measures in response to the emergence of the Omicron variant and the “credible risk” it presents to the NHS. The Clerk will be in touch with all those who have requested attendance to let them know whether or not they may join. • If your attendance has not been confirmed, please do not attempt to gain entry.
Face Coverings	Mandatory as from 13 Dec 2021 (unless when permitted to speak)
NHS Test and Trace App	Check-in to the venue by scanning the QR Code at the entrance
Hand sanitiser	Available to use at the entrance
Free Movement	A staggered entry/exit and one-way system will be in operation. Please follow the Steward’s instructions in this respect.
